CJA162 APOLOGIES AND SUBSTITUTIONS

Apologies were received from Councillor William Buchanan and Councillor Alistair McNeill, Falkirk Council and Councillor Joe Rosiejak, Councillor Alfred Patey, Fife Council.

Councillor Jim Thomson, Stirling Council, substituted for Councillor Paul Owens.

CJA163 QUORUM

The quorum for a meeting of the Fife and Forth Valley Community Justice Authority is seven. Only five Members were present, therefore, the meeting was declared inquorate.

Councillor Matchett raised his concerns regarding attendance at meetings of the Authority and suggested a meeting be arranged to discuss the situation.

The Convenor agreed with these concerns and confirmed a meeting would be arranged in advance of the December Board meeting to discuss attendance and the difficulties inquorate meetings place on the vital decision making of the Authority.

The Convenor suggested that it was in the interest of partners that the meeting continued, with recognition that no decisions could be made. The Minutes would be submitted to the next meeting of the Authority seeking approval of the Recommendations made.

The Clerk confirmed that the Minute would reflect that no decisions could be made but that there was support for the Recommendations to be endorsed and/or discussed at the next meeting. The Members present were agreeable to this suggestion and the meeting continued.

CJA164 URGENT BUSINESS BROUGHT FORWARD BY THE CHAIR

CJA166 MINUTE OF PREVIOUS MEETING

The Minute of the meeting held on Tuesday, 2 June 2009, was acknowledged.

CJA167 WELCOME, INTRODUCTION AND THANKS

The Convenor welcomed Bill Eadie, Head of Social Care, Stirling Council, to the meeting (the Stirling Council representative was previously Des Friel) and Moira Graham, Chair of HMP and YOI Cornton Vale Visiting Committee.

CJA168 PRESENTATION

The Convenor introduced Alan McCloskey, who gave a presentation on the work of Victim Support Scotland.

Councillor Matchett referred to the referrals system in Fife and suggested that it would be desirable to extend the referrals system into other Local Authority areas. Councillor Matchett confirmed that, as Chair of the Joint Police Board, he would raise this item and seek the Police position on this.

It was confirmed that Victim Support would welcome the opportunity to extend the referrals system but it was acknowledged that, as Fife is a unitary Authority with one Police Force, it had been possible to reach agreement on disclosure of information, whereas it was considered that it could prove more difficult in areas which covered more than one Local Authority or Police Force.

The Chief Officer confirmed that she would liaise with Victim Support to see if this best practice could be extended and will report back to the Board.

CJA169

FFV CJA CRIMINAL JUSTICE SOCIAL WORK TRAINING PLAN 2009-2011

Barbara Farrand, FFV CJA Training and Development Officer, was welcomed to the meeting by the Convenor.

It was confirmed that discussions had taken place with the four Local Authority CJS Service Managers in preparing the Plan. The Fife and Forth Valley training plan intends to continue to equip all staff regardless of grade, with the appropriate training to enable them to work efficiently and effectively. It is proposed that current good practise is enhanced where possible with in-house training across Local Authority boundaries. An example of this is Community Service seminars. Staff Development and Education departments will continue to deliver an extensive range of training and the TDO will develop links to enhance opportunities for Criminal Justice Staff.

The Fife and Forth Valley training schedule is necessarily vague with regards to dates, staff number etc, as staff availability for locally focussed training will be heavily dependant upon the National Training Strategy and schedule which is in its final stages of completion.

Due to the vagaries of the National Training Schedule and, in particular, the introduction of LSCMI and the new National Standards which will engage all Training and Development Officers for approximately 6 – 8 months during 2010, the Fife and Forth Valley training Schedule has concentrated on the 'weighted' training needs identified in the training needs analysis. It is proposed to revise this schedule as appropriate post LSCMI and National Standards implementation.

The training schedule relies upon a suitably experienced Training and Development Officer being in post for the period 2010/2011 and the continued support of the other Training and Development Officers and National Trainers.

In line with other Community Justice Authorities, further funding should be sought from central government to cover the costs incurred by the need for ongoing nationally accredited training and findings will be presented to the FFV CJA Board in due course.

Councillor Benny commented that the TNA was very detailed and not necessarily a paper requiring consideration by the Board but should be delegated to CJS Service Managers.

The Convenor confirmed that the Training Plan is delegated to local Lead Officers but recognition of the need to maintain standards with national training requirements was necessary.

The Chief Officer stated that this Report was a follow-up to the Report submitted to the Board on 3 March 2009 and the Recommendation that a Training Plan for CJSW staff be prepared and submitted to a future meeting for information and recognition of the work being undertaken and the resource and budget demands.

Councillor Bill McCulloch enquired whether training needs identified had been met and it was confirmed that the focus had been on national training requirements, however, some local training was ongoing but would need to be improved upon.

Councillor George Matchett stated that he supported the work undertaken at this stage but would want to see TNA conducted under the grant process, though recognised it may not be sufficient for this purpose, and requested that a valuation of cost and outcome is undertaken and presented to the Board.

It was confirmed that a paper was available on national training needs incorporated costs, priorities and release of staff issues etc and that liaison with local and central government was crucial in order to identify funding.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Approve the Training Schedule, based upon the findings of the Fife and Forth Valley Community Justice Authority Training Needs Analysis (TNA).
- 2 The Fife and Forth Valley Community Justice Authority Training Needs Analysis being used to inform the National Training Strategy for Criminal Justice Staff.
- 3 A copy of the National Training Strategy for Criminal Justice Staff be provided to Board Members when completed.
- 4 The Chief Officer making a request to the Scottish Government for further funding towards the training needs identified in the National Training Strategy, should it be required.

FFV CAJ PERFORMANCE REPORT SEPTEMBER 2009

The FFV CJA Research and Information Officer gave the background to the Report. At present, in terms of the data coming from the four Local Authority Criminal Justice Social Work (CJSW) Services, there are three sources of data, each of which differs slightly due to the timing of its production. The sources are as follows:

- Quarterly Returns submitted for the CJA's Local Performance Framework;
- Summary Aggregate Returns produced in April 2009;
- Full Aggregate Returns produced in August 2009.

In future the Board will be provided with quarterly statistical updates based on the Local Performance Framework, which in turn is based primarily on the Quarterly Returns from CJSW Services and the monthly returns from the Scottish Prison Service (SPS).

The FFV CJA Research and Information Officer has been reformatting the Local Performance Framework to take account of recent local changes and demands placed on the CJA by the Scottish Government in relation to the requirement for a National Performance Framework. To this end the FFV CJA Research and Information Officer has been working closely with colleagues from the four Local Authorities and the Scottish Prison Service to define the data required by FFV CJA to populate its Local Performance Framework. This has been an ongoing process, however, by the next FFV CJA Board meeting the Local Performance Framework should be up and running, and this will provide the basis for future quarterly statistical updates to the Board.

The Board should note that the FFV CJA Annual Report, which was written in June 2009, was based on the Summary Aggregate Returns for 2008/9. As such, some of the statistics quoted in this Report may differ from the Annual Report.

The Chief Officer made particular reference to the statistics given on page 27 of the submitted papers and emphasised the importance of including qualitative data as well as quantitative data in reporting.

The Convenor thanked the Research and Information Officer and partners for the work done to-date in producing performance information.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note the contents of the Fife and Forth Valley CJA Performance Report September 2009.
- 2 Request that performance reports be submitted to the Board on a quarterly basis.

MAPPA ANNUAL REPORTS

The Chief Officer confirmed that Mappa Annual Reports would be simultaneously published on Monday, 26 October 2009.

The Mappa Annual Report for 2008-2009 will be the second Annual Report to be published. Guidance produced by the Scottish Government for the Annual Report this year required several changes to be made. This includes a local introduction to the Report rather than a national introduction that was included in the previous Report. There is also information on restricted patients this year. This follows the inclusion of Health Boards as responsible authorities within Mappas from April 2008. Additional information on low risk, Mappa level 1, offenders is also included.

As in the previous year's Report, the Report will focus on:

- What is Mappa, how Mappas work, the roles and responsibilities of agencies and what type of offenders are included in Mappa;
- Statistical information of the offenders who are involved in Mappa, including the numbers resident in Fife and Forth Valley and compliance rates;
- Information from the SPS and how offenders are managed in prison.

The Chief Officer confirmed both a hard copy and electronic copy of the Fife and Forth Valley Mappa Annual Report will be issued to Board Members on the day of publication, along with a copy of the Press Release.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note that Mappa Annual Reports for all eight Community Justice Authority areas will be published by the Scottish Government in October 2009. On the same date that the Reports are published, on the Scottish Government's website, the responsible authorities will also formally submit their Mappa Annual Report to their respective CJA and to Scottish Ministers. Mappa Annual Reports for England and Wales will also be published on the same date.
- 2 The Chief Officer will provide both a hard copy and an electronic copy of the Fife and Forth Valley Mappa Annual Report, on the day of publication by the Scottish Government, to all Members of the Fife and Forth Valley CJA Board. A copy of the Press Release is also to be provided.

MULTI-AGENCY INSPECTION: ASSESSING AND MANAGING OFFENDERS WHO PRESENT A HIGH RISK OF SERIOUS HARM 2009

The inspection agencies of the Police (Her Majesty's Inspectorate of Constabulary Scotland [HMICS]), Prisons (Her Majesty's Inspectorate of Prisons [HMIP]), and Social Work Inspection Agency [SWIA], have jointly undertaken an inspection of offenders who present a high risk of harm.

The inspection team comprised of Inspectors from the three Inspectorates, reflecting the integrated approach expected from the agencies with the responsibility for managing high risk offenders. The findings are presented in the cross-cutting areas of risk assessment, risk management, sharing information and working together effectively.

The 62 offenders involved in the inspection resided across Scotland. Included in the sample were a number of offenders who had committed serious sexual or violent crimes from Fife, Clackmannanshire and Falkirk Council areas. Fife Constabulary was one of the Police Force areas that were also scrutinised in terms of their assessment and management of this group of offenders.

There are 19 Recommendations to this report which will clearly have implications for the four Fife and Forth Valley Local Authorities, Central Scotland Police, Fife Constabulary, NHS Fife, NHS Forth Valley and the Scottish Prison Service (SPS).

Each agency is actively considering the report both individually and collectively through the Multi Agency Public Protection Arrangements (MAPPA). There are two separate Mappas in the FFV CJA area; one in Fife and one in Forth Valley and the two Mappa Strategic Management Groups will ensure all relevant recommendations are addressed appropriately.

The Chief Officer of Fife and Forth Valley CJA is a member of both the Fife and Forth Valley Mappa Strategic Management Groups.

The Chief Officer referred to the FFV CJA Review of Core and Non Core Services and the recommendation that key staff be co-located and noted that this recommendation within the Inspection Report would assist in taking this forward.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note the Recommendations of the Multi-Agency Inspection of the Assessment and Management of Offenders who present a High Risk of Harm.
- 2 Request a progress report on the responsible authorities' response to the recommendations contained in the Report.

FFV CJA AREA PLAN 2011-2014

In terms of Section 3 of the Management of Offenders etc (Scotland) Act 2005 Community Justice Authorities (CJAs) are required to produce Area Plans. Our current Area Plan covers the period 2008-2011. The Scottish Government have now produced a planning framework for CJAs to submit Area Plans for the period 2011-2014 by May 2010.

Already, consultation has taken place with CJA Convenors and Chief Officers with the Scottish Prison Service (SPS) and Local Authorities under the auspices of the Association of Directors of Social Work (ADSW). Whilst CJAs have a number of statutory partners, it is SPS and Local Authorities who are determined to be duty to cooperate agencies in the Management of Offenders (etc) Scotland Act 2005.

The purpose of this initial consultation is to agree with these agencies common high level strategic objectives. Once these are established, each CJA will then require to liaise with local partners to determine and agree local priorities. These will then contribute to the creation of individual CJA Area Plans for 2011-2014 that are supported by all partners. Links will require to be made too with Community Planning Partnerships and their Single Outcome Agreements.

It is intended to arrange several local consultation events with our partners in Autumn/Winter 2009. A draft Area Plan will then be produced for consideration by the CJA Board in March 2010.

The Chief Officer emphasised that the preparation time available was very tight and would, therefore, begin consultation events in the coming months.

Councillor George Matchett referred to page 42 of the submitted papers and, whilst he endorsed the recommendations, he required reassurance that the costs would be definitive and included in budget proposals.

Councillor Bill McCulloch stated that it was important to set aside sufficient time to give consideration to the contents of the Area Plan and suggested a workshop be arranged to take these deliberations forward. The Convenor agreed with this suggestion.

The Chief Officer confirmed the intention to arrange meetings with partners and stated that Board Members would be included in the invitation to attend these events.

Councillor Neil Benny suggested that a seminar was arranged for Board Members, following consultation with partners, to allow their input to the process and emphasised the need to notify Board Members of the date as quickly as possible to ensure full attendance. The Chief Officer agreed to give thought to the arranging of a seminar.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note that Community Justice Authorities are required to submit an Area Plan for the period 2011-2014 to the Scottish Government by May 2010.
- 2 Instruct the Chief Officer to begin consultation with local and national partners to prepare a Draft Area Plan 2011-2014 which should be submitted to the CJA Board in March 2010.
- 3 The Chief Officer gives thought to the arranging of a seminar for Board Members.

IMPLEMENTATION OF CRIMINAL JUSTICE SOCIAL WORK CORE AND NON CORE SERVICES: PROGRESS REPORT

The Fife and Forth Valley Community Justice Authority (FFV CJA) undertook a comprehensive review of the Section 27 Grant it receives for the provision of Criminal Justice Social Work Services across Fife, Clackmannanshire, Falkirk and Stirling Councils. The CJA Board agreed at its meeting on 2 June 2009 that the formula applied by the Scottish Government to determine the grant allocation of core Criminal Justice Services should be applied to all core services and a range of non core services, eg employment services, Programme Delivery (excluding Constructs) and Substance Related Offending.

There were several non core services, particularly Drug Treatment Services, excluded from the Review. Application of the new formula, where applicable, resulted in overall changes being reported to the CJA Board in June 2009.

The FFV CJA Board agreed that the transfer of resources be phased over this year and next year. The transfers are masked, or exaggerated, by the receipt this year of an additional £217,409 from April, and a further £178,424 from July allocated to FFV CJA for community service.

The review of core and non core services contained a number of other recommendations on non core services and actions were agreed in consultation with the Fife and Forth Valley Criminal Justice Service Managers and with other partners, such as APEX and Sacro. It is intended that all actions will be completed by March 2010. The reviews of service delivery will be completed by December 2009 (should there be any changes, this will provide sufficient notice for Local Authorities and partners). Any changes to the delivery of Criminal Justice Social Work core and non core services will be reported to the FFV CJA Board in March 2010.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note the progress being made in implementing the transfer of resources between the Fife and Forth Valley Local Authority Criminal Justice Social Work Services.

CJA175

ADDITIONAL FUNDING FOR COMMUNITY SERVICE

Mr Kenny MacAskill, MSP, Cabinet Secretary for Justice, announced on 23 June 2009 the injection of an additional £1.5 million in this current financial year for the delivery of Community Service Orders. He also announced a further £4 million (£2.5 million new money) to be provided in 2010-2011 for the introduction of new Community Payback Orders, as set out in Section 14 of the Criminal Justice and Licensing (Scotland) Bill.

In an effort to raise the credibility of Community Service Orders where offenders are required to undertake unpaid work in the community, the Cabinet Secretary for Justice provided additional funding of £1 million in 2008-2009. The intention was to increase the speed and immediacy with which offenders commence and complete their Community Service Orders. Existing legislation dictates that offenders must complete their Community Service Orders or unpaid work within 12 months of the sentence being imposed. The Criminal Justice and Licensing Bill intends that offenders will complete the unpaid work, as part of the new proposed Community Service Order, within 6 months.

The additional funding has been invested primarily in the creation of additional Community Service work supervisor posts. These additional posts should enable the four Community Service Teams to improve completion rates. Other investments include purchase of additional vans and equipment.

The challenges for the Criminal Justice Services within Fife and Forth Valley in the coming year to ensure they can meet the demands of immediacy and speedier completion of Community Service are, for example, improving completion rates, acquisition of community service workshops in Clackmannanshire and Stirling and promotion of community service within local communities and with local media.

The Scottish Government undertook an audit of community service across all Scottish Local Authorities from October 2008 to December 2008. The Scottish Government intend to repeat this audit again for the same period this year.

There is considerable expectation from the Scottish Government that the additional investment will lead to improvements in Community Service. The FFV CJA Chief Officer, as Accountable Officer, is expected to ensure the additional sums are invested in community service.

The Chief Officer meets regularly with CJS Service Managers from the Fife and Forth Valley CJS and also meets with their respective Research and Information Officers. Scrutiny of community service performance will be undertaken at these meetings and completion rates of community service will now be examined on a quarterly basis to ensure improvement.

The Service Managers for Criminal Justice Services gave a brief up-date on what has been happening within their Local Authority area.

The Governor, HMP Glenochil, confirmed opportunities to promote good links within communities were constantly being considered, eg new recycling unit.

The Convenor stated that it was the role and responsibility of many groups and agencies to improve links and visibility for community service, including Community Councils, local Groups etc.

Councillor Jim Thomson referred to page 54 of the submitted papers, paragraph 2.4, average hours per week to complete a Community Service Order, and asked what the main barrier would be to meeting the timescale. Staffing, equipment and vehicles were suggested as the main barriers and the Service Manager for CJS, Clackmannanshire Council, confirmed that funding for more staff had been provided as well as funding for a new van.

The Service Manager for CJS, Stirling Council, confirmed that funding is a main issue but a review of systems to ensure they were fit-for-purpose was also required.

The Service Manager for CJS, Falkirk Council, confirmed four Workers would take up post in the coming month and the purchase of additional equipment and a vehicle would also ensure an improvement.

The Convenor thanked the Service Managers for taking forward these improvements.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Note the additional grant allocation for Community Service for 2009-2010.
- 2 Note that an additional £4 million will be provided nationally to CJAs in 2010-2011 for the introduction of Community Payback Orders (as set out in Section 14 of the Criminal Justice and Licensing (Scotland) Bill).
- 3 Request that scrutiny of community service completion rates continue and that a report on the same is submitted to the Board in December 2009.
- 4 Request that a copy of the audit report on community service, that will require to be submitted to the Scottish Government in early 2010, be presented to the FFV CJA Board.

FFV CJA DRAFT STATEMENT OF ACCOUNTS 200802009 FOR SUBMISSION TO AUDITORS

Fife and Forth Valley CJA and the Chief Officer are responsible for preparing financial statements in accordance with the Management of Offenders etc (Scotland) Act 2005 and regulations made there under. The Chief Officer is also responsible for ensuring, as Accountable Officer, the regularity of expenditure and receipts and is dependant upon internal financial controls both within the CJA financial arrangements and those within the four constituent Local Authorities.

The purpose of the Statement of Accounts is to present a summary of the financial activities of the Fife and Forth Valley CJA for the benefit of Board Members and Officers of the constituent Local Authorities and the general public. The overspend identified was met from resources within the four respective overspending Local Authorities.

The Draft Statement of Accounts for Fife and Forth Valley CJA require to be submitted to the Auditors by 30 September 2009. In accordance with the Management of Offenders etc (Scotland) Act 2005, the Audited Accounts will then require to be laid before the Scottish Parliament.

The Fife and Forth Valley CJA also receives a Grant from the Scottish Government for Administration purposes and the identified underspend will be repaid to the Scottish Government.

Three of the four Fife and Forth Valley Local Authorities' Accounts for their respective Criminal Justice Social Work grant allocations have been audited by their respective Auditors. The FFV CJA Finance Review Group will address the comments expressed by the Auditors.

An error in the Administration Grant allocation was noted on page 62 of the submitted papers, paragraph 2.4; the allocation is £202,316.

An up-date to paragraph 2.8 of the submitted report was given; Fife Council's Accounts have now been audited, with no comments from the Auditor.

Councillor Neil Benny expressed concern that the Accounts could not be approved due to the meeting being inquorate. The Convenor confirmed that the Accounts must be received by the end of September 2009, therefore, it was now necessary for an executive decision to be made to approve and submit the Accounts to meet this deadline.

Recommendation(s)

It was recommended that the Authority agree to:

- 1 Approve the Draft Statement of Accounts for Fife and Forth Valley CJA for 2008-2009 for submission to the Auditors.

CJA177

COMMUNITY JUSTICE AUTHORITY ADMINISTRATION MONIES

Fife and Forth Valley Community Justice Authority is receiving up to £202,310 in 2009/10 from the Scottish Government for the normal running costs of the CJA. This funding is provided under Section 4 (6) of the Management of Offenders Etc (Scotland) Act 2005 and is separate to the monies allocated to fund the Criminal Justice Social Work Services. This money is paid to Clackmannanshire Council as lead authority on Finance.

The draft final position is a £3,000 overspend. This is the first time that Fife and Forth Valley CJA is expecting a full staffing compliment for the full year and as such the budget is going to be extremely tight.

The Chief Officer confirmed consultation had taken place between the eight CJA Chief Officers and a collective letter had been sent to the Scottish Government requesting reimbursement of audit fees. If this request is successful, it would alleviate the anticipated overspend position in the FFV CJA Administration Grant allocation.

Councillor Matchett asked for a breakdown to prepared of the charges incurred by each CJA for HR, legal and finance support etc, as an exercise in ensuring best value.

Recommendation(s)

- 1 Note the draft financial position at end of July 2009 regarding Fife and Forth Valley Community Justice Authority Administration Grant.

It was noted that Fife, Falkirk, and Stirling Councils have implemented single status and this is reflected in the current expenditure, however, Clackmannanshire Council have yet to implement single status and the cost is still to be determined.

Any expenditure over the grant allocation is the liability of the respective individual Local Authorities.

Background

Review

- 2.3 The FFV CJA Strategic Management Group continues to exist; the Operational Management Group has been removed and replaced by a variety of business and thematic groups. The FFV CJA Strategic Management Group has representation at senior manager level from all FFV CJA statutory partners.
- 2.4 The business and thematic groups enjoy membership of a range of appropriate partners and these groups will report to the FFV CJA Strategic Management Group on a regular basis.

- 2.5 The relationship FFV CJA has, or is developing, with the Fife and Forth Valley Local Authority Community Planning Partnerships, the Fife and Forth Valley Alcohol and Drug Partnerships, the Fife and Central Criminal Justice Boards and the Fife and Forth Valley Mappa Strategic Management Groups is also recognised. The work of these Groups is clearly related to our CJA.
- 2.6 Terms of Reference for each Group are currently being developed and agreed.

3 CONSULTATION

- 3.1 Consultation has taken place with all partners and they are supportive of the changes.

4 RESOURCE IMPLICATIONS

- 4.1 The changes should remove duplication of effort and ensure more efficient use of time for the Chief Officer and partners.

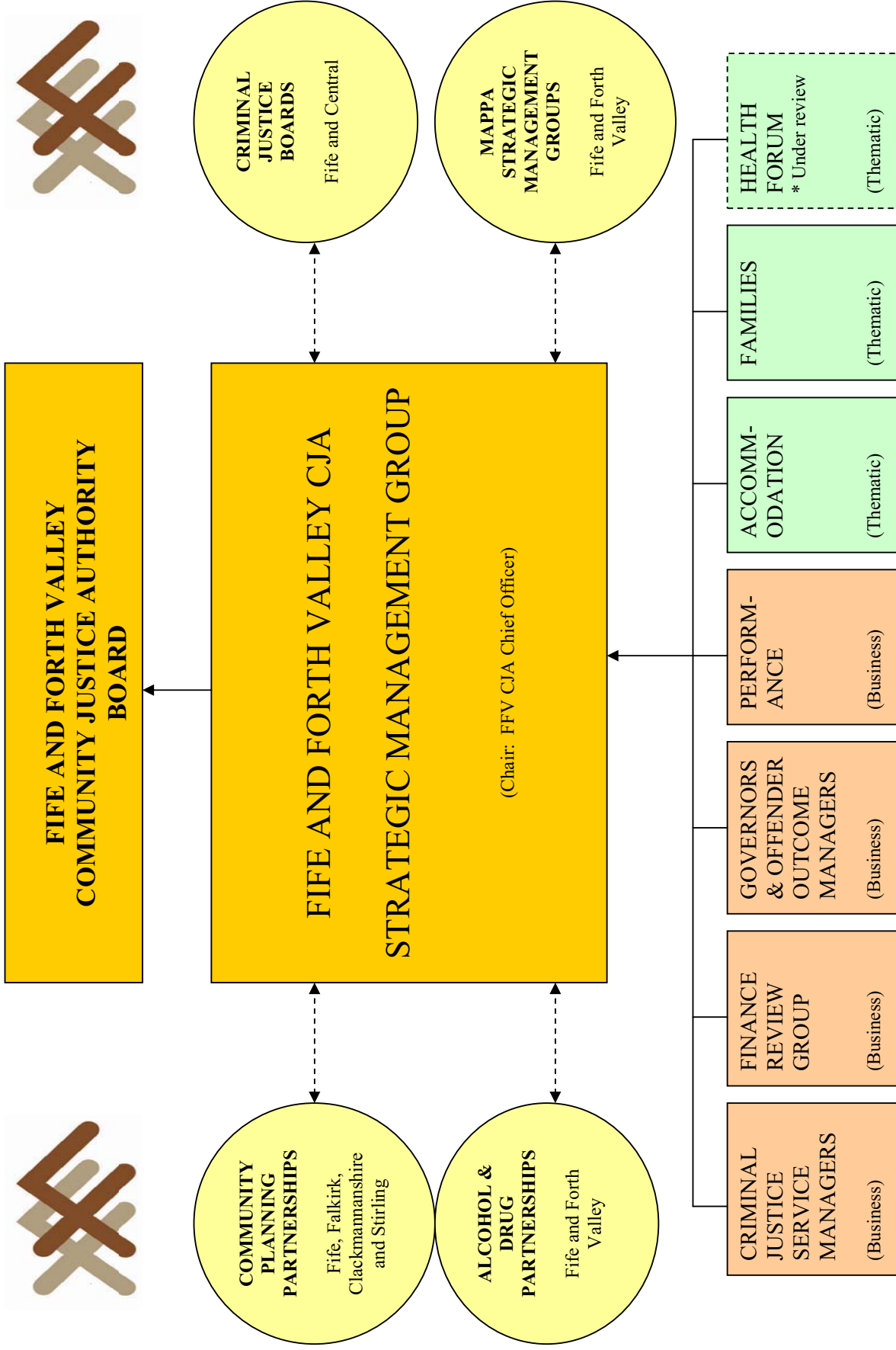

1 RECOMMENDATION(S)

- 1.1 Board Members are asked to approve the Action Plan for Fife and Forth Valley Community Justice Authority for 2010-2011, attached as an Appendix to this Report.

2 CONSIDERATIONS

- 2.1 Each CJA was required to provide an Area Plan for the period 2008-2011 under S3(5)(a) of the Management of Offenders etc (Scotland) Act 2005. The Area Plans were approved by Scottish Ministers in December 2007. The Action Plans for 2008-2009 and 2009-2010 were approved too.
- 2.2 While the Area Plan for the full three-year period 2008-2011 has received ministerial approval, the grant allocation for each CJA will continue to be issued on an annual basis. The notification of grant allocation will continue to be on the basis of the submission of acceptable Annual Reports and Action Plans.
- 2.3 To enable the Scottish Government to determine and notify the CJA in January 2010 of the grant allocations for 2010-2011, CJAs were required to submit an Action Plan for 2010-2011 by September 2009.

Content of Action Plan

- 2.4 The FFV CJA Action Plan is expected to reflect the priorities and ambitions of the National Strategy for the Management of Offenders. It should also be clearly based on the objectives of the Fife and Forth Valley Area Plan for 2008-2011.
- 2.5 A copy of the Action Plan for 2010-2011 is attached as an Appendix to this Report. The Plan focuses on a range of themes. These include:

- Setting priorities;
- Area of improvement;
- Efforts for HMPs Cornton Vale, Glenochil and Polmont to become community facing prisons;
- Extending the delivery of offence-focussed programmes across the CJA, both in the community and in prison;
- Developing strategic links with community planning partnerships;
- Implementation of a Unified Courts Administration in Fife and Forth Valley Courts;
- Provision of a Training Strategy and Annual Report of Training.

2.6 Many actions are continued from our previous Action Plans; other actions are informed by outstanding areas contained within the existing Fife and Forth Valley CJA Area Plan 2008-2011. There are also new actions that are influenced by the proposed new legislation to reform community sentences.

Examples include:

- Increase the number of Fife and Forth Valley prisoners located at HMP Glenochil;
- Maintain links with the new Fife and Forth Valley Alcohol and Drug Partnerships;
- Increase the level of community engagement in determining community service placements.

Format

2.7 The format of the Action Plan has been amended from previous years to more clearly illustrate lead responsibility, planning group responsibility, link with National Outcomes as per the Single Outcome Agreements and progress.

Monitoring

2.8 The Local CJA Performance Framework will be reviewed to ensure all relevant information for the Action Plan can, where appropriate, be collected and monitored.

2.9 The Action Plan will be monitored on a regular basis by the Fife and Forth Valley CJA Strategic Management Group and other FFV CJA business and thematic groups, as appropriate.

2.10 An up-date on the progress of the Action Plan for 2010-2011 will be completed in October 2010 and reported to the Board.

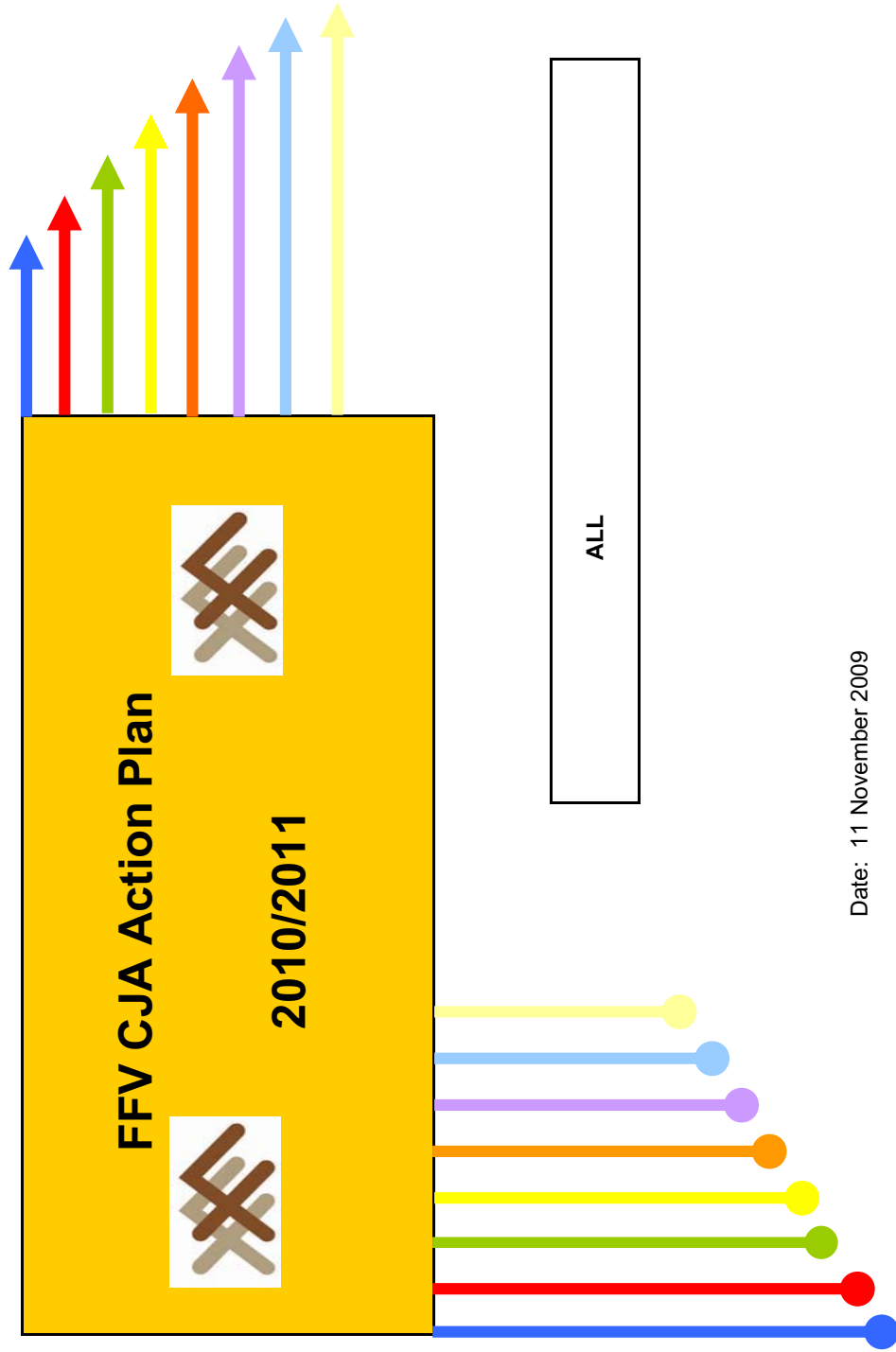

2 CONSIDERATIONS

- 2.1 Each CJA was awarded £190,000 by the Scottish Government for each year of their three-year Area Plan 2008-2011. The intention was that the money should be used to develop priorities outlined in the CJA Area Plan.
- 2.2 The Fife and Forth Valley CJA Board agreed that the £190,000 should be allocated in the following way:

- 2.3 Approval for these service development proposals was given by the Scottish Government on 11 April 2008. Thereafter, arrangements were made for the four service developments to be initiated.

PROGRESS TO-DATE

Supported Accommodation

- 2.4 Three Tenancy Support Worker posts were created, one fulltime post each for Falkirk and Fife and 0.5 posts each for Clackmannanshire and Stirling Council Criminal Justice Services. Each Local Authority required to create these posts, in some cases seeking approval through their relevant Council Committee structures. This resulted in significant delays in recruiting to these posts and a subsequent underspend in the grant allocated for these posts in 2008-2009. All posts have been filled during this current financial year and the projected spend is as illustrated below in Table 1. The overspends relate to the increase in salary costs due to a combination of pay rises and changes to salaries following the introduction of single status.

Enhanced Groupwork

- 2.5 3.6 WTE posts were created to increase the number of groupwork programmes delivered across Fife and Forth Valley for sex offenders and domestic abuse. Similar delays were experienced in creating posts and an underspend was also reported for 2008-2009 for this area of work. All posts for enhanced groupwork have been fully occupied this year and the projected spend is illustrated below in Table 2. The reason for the overspend is similar to that provided for the Tenancy Support Worker posts.

Enhancement of Mappa

- 2.6 It was agreed that the CJA would contribute £10,000 towards the creation of an additional post in Fife to strengthen Mappa arrangements, particularly in terms of quality assurance. If successful, the intention was to extend this arrangement to Forth Valley.
- 2.7 This post has now been created in Fife but the full costs are now being met by Fife Council, Fife Constabulary and NHS Fife. There has been no need for the FFV CJA contribution. Discussions have taken place with partners in Forth Valley to create a similar post in that area. It has been agreed to defer any decision until a review is undertaken on the merits of such a post after a 12 month period. The deferment of any decision will result in no spend being incurred against the £10,000 allocation.

Transport

- 2.8 The issue of improving transport arrangements for prisoners' families to HMP Glenochil has proved to be a challenging issue. Numerous meetings have taken place since April 2008 involving a variety of statutory partners and still no solution has been identified. The £7,400 allocated last year incurred no spend despite the best efforts of our partners. The Scottish Government withheld the same amount this year from the FFV CJA Service Development Grant, although agreement was reached that if plans progress and a sum up to £7,400 is required, the grant will be reinstated.

Proposals for Underspend

- 2.10 Discussions have taken place with Criminal Justice Service Managers and Finance Officers from the four Fife and Forth Valley Local Authorities and it is proposed that the underspend be allocated as follows:

- The overspend in supported accommodation and groupwork should be met from the underspend in the Mappa allocation.
- The remaining underspend (£3,917) within Mappa should be allocated to the Circles of Support and Accountability pilot project that is to be introduced in Fife. This project has the full support of the Fife Mappa Strategic Management Group (Offender Management Group). The project will strengthen the supervision and monitoring arrangements of sex offenders and could be extended to the Forth Valley area.

3 CONSULTATION

3.1 As noted at paragraph 2.7, consultations took place with the Criminal Justice Service Managers of the four Fife and Forth Valley Local Authorities and the Governors and staff of the three Forth Valley prisons.

1 RECOMMENDATION(S)

Board members are asked to:

- 1.1 Note the progress of the four Fife and Forth Valley Local Authority Criminal Justice Services in improving their performance in relation to Community Service.
- 1.2 Request a report on the performance of the four Fife and Forth Valley Local Authority Criminal Justice Services in relation to the national audit of Community Service.
- 1.3 Request that regular scrutiny of community service performance continues to be reported to the Board on a regular basis.
- 1.4 Request that the four Fife and Forth Valley Local Authority Criminal Justice Services continue to actively promote Community Service.

2 CONSIDERATIONS

Background

- 2.1 In 2008-2009 the Scottish Government injected an additional £1 million to the national budget for Criminal Justice Social Work Services. The purpose was to increase the speed and immediacy with which offenders commence and complete their Community Service Orders (CSO's). A further £1.5 million was also added this year to further improve Community Service Orders.
- 2.2 Proposed legislation, the Criminal Justice and Licensing Bill, will require Community Service Orders to be completed within a 6 month period: existing legislation allows for a 12 month completion period. Consultation with communities regarding the nature of work to be undertaken will also be required.
- 2.3 Reports on the additional funding for Community Service and the Community Service Visibility Project have previously been provided to the Fife and Forth Valley CJA Board. Board Members requested that scrutiny of the performance of the Community Service continue.

Performance

- 2.4 The greatest challenge for the four Fife and Forth Valley Local Authorities will be to ensure offenders commence their CSO's within 5 days and complete their orders within 6 months. Table 1 below illustrates the completion rates across the four Fife and Forth Valley Local Authorities. From the new money allocated to Community Service, each Local Authority has invested in the creation of additional Community Service Work Supervisors. In some Local Authorities there has been a delay in establishing and recruiting to these new posts. The four Local Authorities are confident, however, that the performance in the next 2 quarters, ie from October 2009 to March 2010 should allow them to meet the targets to ensure offenders can complete their CSO's within 6 months.

- 2.5 Table 2 below provides information on the number of CS and Section 229 Orders imposed since April this year. This compares favourably with the figures for 2008/09 where a total of 1195 CS and Section 229 Orders were imposed over the full year. Improvement is required in the time taken for offenders to begin work in all areas except Clackmannanshire. Criminal Justice Service Managers are confident this issue will be resolved with the additional CS Work Supervisors being in post. The number of hours of unpaid work undertaken across the Fife and Forth Valley area amounts to a very considerable sum. Discussions are taking place with Criminal Justice Service Managers as to how these figures can be promoted in the local media alongside the range of work undertaken.

2.6 The nature of work undertaken by offenders on Community Service is diverse. Projects undertaken include house clearances, removals and decoration, gardening, litter picking, graffiti removal, laying of paths, leaflet drops, assisting in charity shops and other environmental work. Beneficiaries include a range of voluntary organisations, Community Councils, individuals such as older people or those with disabilities. Requests for work continue to be received on a regular basis. Numbers are contained in Table 3 below.

2.7 **Promotion of Work**

Collectively there have been 15 reports in the media promoting the work undertaken by offenders on community service. Much of this has been in the local press but there has been national coverage too. A visit by Mr K MacAskill to a project in Falkirk attracted national press interest as did the new graffiti removal project in Stirling which was also reported by the BBC on their website. Efforts to promote the work undertaken by offenders will continue to be made by FFV CJA and the four Local Authorities. The four Local Authority Communications Units have all been very supportive in promoting community service.

The Scottish Government are still considering the outcomes of the Community Service Visibility pilot projects, one of which was the Fife and Forth Valley. To aid the profile of Community Service and level of knowledge and understanding within communities the Scottish Government are actively considering a national campaign and national branding of unpaid work.

2.8 **Continued Improvement**

Efforts will continue across the four Local Authority Criminal Justice Services to ensure readiness for the new demands of the proposed legislation. Regular scrutiny of all areas of performance in relation to community service will continue. The Scottish Government undertook a national audit of community service from October to December 2008 and this will be repeated over the same period this year; a report on the audit will be provided to the Board.

3 CONSULTATION

3.1 Consultation has taken place with the Criminal Justice Service Managers from the four Fife and Forth Valley Local Authorities.

4 RESOURCE IMPLICATIONS

4.1 In the past two years, 2008-2009 and 209-2010, Fife and Forth Valley CJA have received sums totalling £501,571 for Community Service.

1 RECOMMENDATION(S)

Members of Fife and Forth Valley Community Justice Authority Board are asked to:

- 1.1 Endorse the contents of the Fife and Forth Valley CJA Local Performance Framework, updated to include Quarter 2 2009/2010 data.

2 CONSIDERATIONS

- 2.1 The performance figures for the first 6 months of 2009/2010 are attached as an Appendix to this report. Performance trends that are of particular interest are noted below.
- 2.2 Number of liberations remained stable-261 in Q2 compared with 265 in Q1. There was a relatively large increase in liberations in Clackmannanshire-29 in Q1 rising to 40 in Q2.
- 2.3 There was a reduction in liberations from short-term sentences-92 in Q2 compared with 114 in Q1. The majority of this reduction occurred in Fife and Falkirk.
- 2.4 There was a reduction in the number of SERs submitted to court-1343 in Q2 compared with 1464 in Q1, a reduction of -8%. Only Clackmannanshire showed an increase.
- 2.5 The percentage of SERs submitted to court by the due date is high in all local authorities: Clacks 94.2%, Falkirk 99%, Stirling 99.2% and Fife 98.9%. As such the average for the CJA is 97.8%.
- 2.6 There was an overall reduction in the number of Probation Orders imposed across the CJA-275 in Q2 compared with 342 in Q1, a reduction of 20%. Only Falkirk showed an increase.
- 2.7 There was an overall reduction in the number of CSOs imposed across the CJA-202 in Q2 compared with 258 in Q1. However, S229s actually increased over the same period. All areas showed a reduction in CSOs imposed, and only Clacks showed a reduction in S229s.

- 2.8 There was an overall increase in the average number of hours per week taken to complete CSOs (inc. s229s)-3.37 hours (average for the CJA) in Q2 compared to 2.76 in Q1. However the increase was mostly due to an increase in Stirling from 3.32 hours to 5.27 hours.
- 2.9 The number of offenders receiving supported accommodation services increased across the CJA-101 offenders in Q2 compared with 86 in Q1. All local authorities showed an increase.
- 2.10 The number of referrals to APEX reduced across the CJA-117 in Q2 compared with 181 in Q1.
- 2.11 The number of DTTOs and Fast Track orders imposed across the CJA remained stable-16 DTTOs and 12 FT in Q2 compared with 18 DTTOs and 12 FT in Q1.
- 2.12 There was a reduction in the number of prisoners receiving voluntary throughcare-40 in Q2 compared with 50 Q1. All Local Authorities showed a reduction, except Clackmannanshire, which increased from 0 in Q1 to 2 in Q2.
- 2.13 Performance figures for each quarter will be reported to the Board on a regular basis.

RECONVICTION RATES IN 2005/2006 COHORT	

1 RECOMMENDATION(S)

Board Members are asked to:

- 1.1 Note the main findings of the report on reconviction rates in Scotland for the 2005/06 cohort that are relevant to the FFV CJA.
- 1.2 Note, from the outset, that the 2005/2006 cohort and subsequent trends in reconvictions pre-date the formation of Community Justice Authorities.
- 1.3 Note that at this time reconviction data is only a proxy measure for re-offending.
- 1.4 Request that the Chief Officer discuss the reconviction rates with Central Scotland Police, Fife Constabulary and the four Community Planning Partnerships within the Fife and Forth Valley area.

2 CONSIDERATIONS

National Picture

- 2.1 National reconviction rates after 2 years have stabilised at 45% since 2002/3; and similarly the 1-year reconviction rate for the 2006/7 cohort is very similar to that of the previous year (32.2% compared to 32.5% for 2005/6).
- 2.2 Major influencing factors for reconviction are: age, gender, previous convictions, type of crime committed, type of sentence issued, and length of custodial sentence.
- 2.3 Those sentenced to a DTTO or Restriction of Liberty Order (RLO) are the most likely to be reconvicted within 2 years (81% and 68% respectively) compared to those given a Community Service Order (42%) or a monetary penalty (41 %).

Local Picture

- 2.4 Fife and Forth Valley CJA has the highest reconviction rate of all CJAs with 49% of offenders being reconvicted within 2 years. An increase of 4% on the 2004/5 cohort.

- 2.5 Central Scotland Police has the highest reconviction rate of all eight forces (50%).
- 2.6 Fife Constabulary (and Fife Council, co-terminus) has a reconviction rate of 46%, close to the national average.
- 2.7 Clackmannanshire had the highest reconviction rate after two years of all Local Authorities in Scotland (55%). Falkirk had the second highest reconviction rate (50%)

Statistical Summary

- 2.9 Despite the high percentage of reconvictions in Clackmannanshire the actual volume of reconvictions is comparatively low, accounting for only 10.8% of persons reconvicted in Fife and Forth Valley CJA area.
- 2.10 The data would, therefore, suggest that this smaller group of offenders is more prone to being reconvicted, than in other areas of Fife and Forth Valley and, indeed, nationally.
- 2.11 As the study is of reconvictions not re-offending the reasons for this must consider factors wider than the behaviour of the offenders and consider systemic and procedural factors present in Clackmannanshire, for example police detection rates and fiscal and court policies.
- 2.12 Reconviction rates by Local Authority areas in FFV CJA and comparisons to Scotland and other Local Authorities.

- 2.13 At each of the tracking periods (6 months, 1 year, 2 years) Clackmannanshire was amongst the highest reconviction rates in the nation. At the 6-month period Clackmannanshire (along with Dundee City) had the highest reconviction rate. However whilst Dundee City had relatively average increases in reconviction rate over the next two periods, Clackmannanshire remained amongst the highest in the nation.
- 2.14 As such, in Clackmannanshire, compared to other areas, more offenders (by percentage not volume) are being reconvicted earlier, but then this high rate continues over the two-year tracking period.
- 2.15 Crime rates per 10,000 population covering period of 2005/6 cohort:

- 2.16 Between 2005/6 and 2006/7, a period which relates to the 6 month and 1 year tracking periods, the overall rate of crime nationally reduced. However, in Clackmannanshire, Falkirk and Stirling the crime rate increased.
- 2.17 In Clackmannanshire the rate of all crime increased from 799 to 1009 crimes per 10,000 population - an increase of 210 crimes per 10,000 population. In terms of volume, this was an increase from 3887 to 4932 (+1045) crimes.

1 RECOMMENDATION(S)

Board Members are asked to:

- 1.1 Note the draft financial position at end of September 2009 regarding the Fife and Forth Valley CJA Administration Grant, attached as Appendix 1 to this Report.
- 1.2 Request that the Scottish Government be notified of potential financial pressures in the FFV CJA Administration budget for 2010-2011.
- 1.3 Note the table of CJA support costs, attached as Appendix 2, as requested at previous Board meeting.

2 CONSIDERATIONS

- 2.1 Fife and Forth Valley Community Justice Authority is receiving up to £207,316 in 2009/10 from the Scottish Government for the normal running costs of the FFV CJA. This funding is provided under Section 4 (6) of the Management of Offenders Etc (Scotland) Act 2005 and is separate to the monies allocated to fund the Criminal Justice Social Work Services. This money is paid to Clackmannanshire Council as lead authority on Finance.
- 2.2 Appendix 1 contains a breakdown of the actual spend against this budget for 2009/10. The draft final position is that we anticipate spending our full allocation. This is the first time that Fife and Forth Valley CJA is expecting a full staffing compliment for the full year and, as such, the budget is extremely tight.
- 2.3 The Chief Officer's request for an additional £5k from Scottish Government, in respect of audit fees, has been approved.
- 2.4 This report does not include details of the costs relating to the tribunal of the previous Chief Officer. These costs are being reclaimed from the Scottish Government as and when they come in.

- 2.5 The FFV CJA Administration budget for 2009-2010 was essentially the same amount as that allocated for 2008-2009, no uplift was provided for inflation or any salary increases. Additional funds will require to be provided for 2010/2011 to enable the FFV CJA to fully meet its administration costs. Salary inflation, increased pension costs and the increase in VAT rate are going to be the main pressures on next year's administration budget. With very little scope for scaling back expenditure it is going to be critical that FFVCJA receives some uplift for 2010-2011. It is proposed that a detailed estimate of next year's requirement be submitted to the Scottish Government in advance of the grant allocation.

Support Costs

- 2.6 At the previous Board meeting on 8 September 2009, Board Members requested that a comparison be undertaken across the eight CJAs in Scotland in relation to payments for support costs. The costs paid by each CJA is listed in Appendix 2 to this Report. As can be seen from the Appendix, there are a variety of arrangements in existence between CJA and Local Authorities in relation to the provision of Legal, HR, Committee/Board support and Finance services. The costs charged by Local Authorities vary from a flat fee for all support service provision to hourly rates. The total cost paid by Fife and Forth Valley is sixth highest across the eight CJAs. This is largely attributable to the payment to Clackmannanshire Council for 0.5 WTE of a Finance Officer post. Clackmannanshire Council is the lead Council for the CJA and is responsible for the receipt, monitoring and distribution of the CJA Grants from the Scottish Government. No similar arrangement exists in any other CJA. This arrangement does, however, provide benefits in having a dedicated Officer who is available to undertake a variety of tasks when required. A good example of this is the financial projections that were required when the CJA undertook the review of core and non core Criminal Justice Social Work Services.

3 CONSULTATION

1 RECOMMENDATION(S)

- 1.1 To note the projected outturn position for financial year 2009-2010 regarding Fife and Forth Valley CJA Section 27 Grant.

2 CONSIDERATIONS

- 2.1 Criminal Justice Social Work Services are funded via a ring fenced grant from the Scottish Government. Chief Officers of the CJAs, as budget holders, are responsible for the effective financial management of the funds allocated to their CJA, including internal resource allocation across the constituent Authorities.
- 2.2 The Appendix shows a total projected expenditure outturn of £791,490 over grant allocation.
- 2.3 In Fife Council the projected expenditure outturn is £653,722 over grant allocation. Fife Council overheads are £650,000; Fife council allocate the full grant and effectively subsidise the expenditure by the overhead amount.
- 2.4 In Falkirk Council the projected expenditure outturn is £48,528 over grant allocation. Core budget is expected to spend £22,052 over the grant allocated, again due to workload demand exceeding the grant allocated. Non-core is expected to spend £26,477 over grant allocated, due to an overspend in Constructs, and an overlap in Young Offenders Projects. Falkirk Council will be subsidising the Section 27 Grant to the value of the overspend.
- 2.5 In Stirling Council the projected expenditure outturn is £101,557 over grant allocation. The Core is expected to be £86,612 over in total, in addition to workload exceeding grant this is mainly due to the cost of single status. Stirling Council has set aside funds to subsidise for the extra cost of single status. Non Core is expected to be over by £14,946 in total, mainly due to an overlap in Young Offenders Projects.
- 2.6 In Clackmannanshire Council the projected expenditure outturn is £2,318 under grant allocation. The Core is expected to be £14,526 over in total, due to several small overspends. Non Core is expected to be under by £16,844 in total due to a delay in appointing a post within MAPP. Work is ongoing to look at ways in which the MAPP underspend can be utilised, possibly involving the use of sessional staff to clear backlogs.

- 2.7 Fife, Falkirk, and Stirling Councils have implemented single status and this is reflected in the current expenditure. Clackmannanshire has yet to implement single status, the cost of this is not known.
- 2.8 Any expenditure over the grant allocation is the liability of the respective individual Local Authorities.
- 2.9 In November 2009, each CJA in Scotland was allocated £15,000 to support a self-evaluation process for the Caledonian System; this is a groupwork programme for men convicted of domestic abuse. The self-evaluation has to be completed by Friday, 12 February 2010 and will be the basis on which future funding is allocated. The additional allocation will be reflected in the financial spreadsheets provided to the Board at its next meeting.

1 RECOMMENDATION(S)

2 CONSIDERATIONS

- 2.1 Fife and Forth Valley CJA Board approved the Action Plan for 2009-2010 at a Board meeting on 16 September 2008. A progress Report was to be completed in October 2008 and submitted to the FFV CJA Board.
- 2.2 The Fife and Forth Valley CJA Action Plan for 2009-2010 was influenced by the priorities and ambitions of the National Strategy for the Management of Offenders and the objectives of the Fife and Forth Valley Area Plan 2008-2011.

Progress To-Date

- 2.3 The Action Plan for 2009-2010 is attached as an Appendix to this Report. The Action Plan notes, in the final column headed status, the progress for each action. Some actions are completed, many are ongoing and a few remain outstanding.
- 2.4 Examples of completed work include:
 - Introduction of a housing protocol for prisoners;
 - Establishment of a groupwork team in Fife Criminal Justice Services.
- 2.5 Examples of ongoing work include:
 - Monitoring of performance;

- Establishing links with Community Planning Partnerships.

2.6 Areas outstanding are:

- Expansion of offender tracking services;
- Establishment of Forth Valley Employment Forum.

Outstanding areas of work will be addressed as soon as practicable.

New Demands

2.7 Since the Area Plan was approved in September 2008 there has been a variety of areas of work the Chief Officers and partners have been involved in that are not captured by the Action Plan. This includes work generated by the Scottish Government's policy review Fair, Fast and Flexible Justice to improve the speed and efficiency and credibility of community penalties. Considerable effort has been put into areas such as the Community Service Visibility Project and the SER Pilots.

Monitoring

2.8 The FFV CJA Action Plan is monitored on a regular basis by the FFV CJA Strategic Management Group and other FFV CJA business and thematic groups.

3 CONSULTATION

3.1 Consultation has taken place with all Fife and Forth Valley CJA partners.

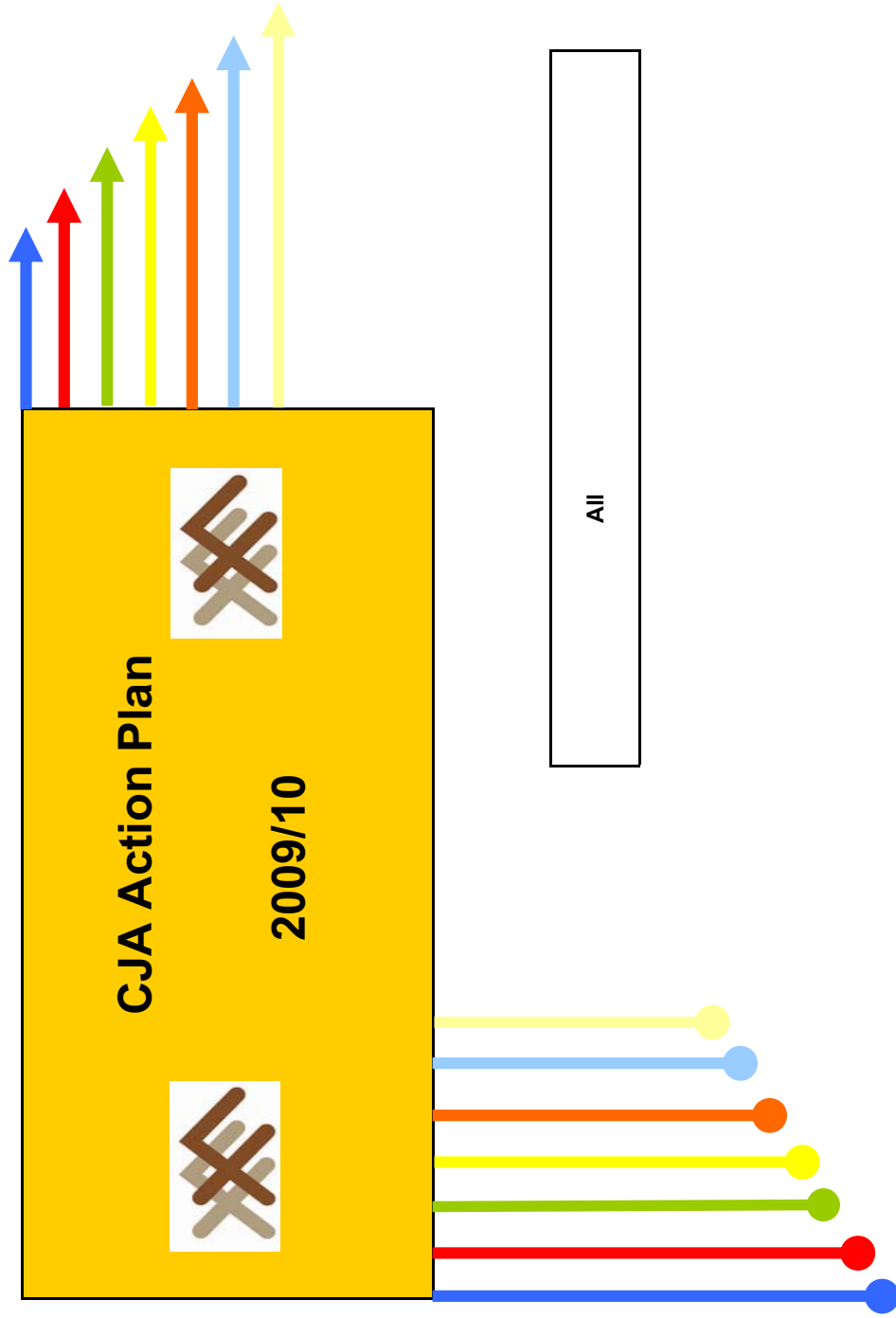

- 1.1 Note the contents of the Scottish Crime and Justice Survey (SCJS) 2008-9 as it relates to the work of the Community Justice Authority, in particular in relation to Public Perceptions of Crime and Community Sentences.

2 CONSIDERATIONS

Sample Size

- 2.1 The sample size for the survey is 16,000 people, which is a large increase from the 5000 persons in previous samples. The increase in sample size increases the statistical reliability of the estimates produced by the survey.

Crime as a Social Issue

- 2.2 The public viewed drugs and alcohol as a bigger problem than crime, with 71% and 76% stating that alcohol and drug abuse was 'a big problem' and 53% stating that crime was 'a big problem'.
- 2.3 Women and older people (60+) actually have less of a risk of being a victim of crime, however a higher proportion stated that crime was a big problem. Therefore, something other than their likelihood of being a victim is influencing their perception.
- 2.4 69% of people perceived the crime rate in their local area has reduced or stayed the same over the last two years. This is a statistically significant increase on the 65% baseline recorded in 2006.

Prosecution

- 2.5 In 56% of crimes measured by the SCJS in 2008/9 victims said that the offender should be prosecuted in court.
- 2.6 The victim's opinion will almost entirely depend upon the type of crime they experienced.

- 2.7 Even where victims thought prosecutions should be pursued only 23% believed that the offender should be given a prison sentence.

Non-Prosecution and Alternatives

- 2.8 In 42% of crimes measured by the SCJS in 2008/9 victims said that the offender should not be prosecuted in court.
- 2.9 Again, the view is affected by the nature of the crime; in particular, this view seems to be held by victims of low-level or trivial crime rather than serious crime.
- 2.10 Popular alternatives included warnings (22%), offenders apologising (20%), compensation (15%), and reparation to the community (11%).

Knowledge of Community Sentences

- 2.11 When asked about the range of community sentences, without being prompted by a list of options, the most recognised was community service (79%), followed by electronic tagging (32%).
- 2.12 When prompted DTTOs (44%), compensation orders (42%) and SAOs (29%) were the least well-known community sentences.
- 2.13 Television (73%) and Newspapers (73%) were the most common source of awareness regarding community sentences, with only 17% of people gaining their knowledge of community sentences from the radio.

Attitudes to Community Sentences

- 2.14 Public attitudes to community sentences are mixed. The survey suggests that there is a place for community sentences, particularly in relation to minor crime (84%). However, 63% of people agreed that community sentences do not punish offenders enough.
- 2.15 In terms of the effectiveness of community sentences, electronic tagging (28%) was seen as the most effective means of preventing further crimes being committed by the offender.

Attitudes to Prison Sentencing

- 2.16 Public attitudes to prison sentences are also mixed. The survey suggests that people believe that putting offenders in prison protects the community (89%) and that it is a good way to punish offenders (79%). However, people also agreed that prison does not discourage offending (63%) and that in prison offenders learn new ways of offending (81%).
